I have been a member of the EB for two years and the majority EB has always worked to keep the reunion costs down. The more involved I get the more important this is as each year more of us are on fixed incomes. Keep the cost in mind as you read on.

In the fall of '06 the plan was the '07 reunion would be in Chicago. At the March '06 reunion meeting we were presented with room rates of \$125, more than double St. Louis. Also we would have had to pay for hospitality room, and any food or beverage would have had to be purchased through the hotel at a considerable markup. All in all the additional charges for our functions would have resulted in costs far in excess of what we have to pay the St Louis Plaza Hotel.

The '08 reunion was to be in Nashville but our man on the ground who was going to chair it has issues with his business (partner's health) that are preventing him from chairing the '08 reunion.

When Darryl Stevens and I sat with the St. Louis convention people to sign the '07

reunion contract, I asked if they would freeze our rates for the next five to ten years if we would agree to stay, or make St. Louis our permanent reunion home. After manager choked and nearly fell off her chair she regained composure and said she would have to talk with the complex manager. As I went upstairs I passed the complex manager and told her what her convention people would be asking her for, on behalf of the 281st. Figured I might as well get them all off balance at the same time. She was shocked, so that looked good to me. She immediately set up two tables, gathered her people and literally in two minutes we were in negotiations.

At this point one of our problems was where to store all the 281st stuff. Last year Gary Stagman let us use half of his storage unit but it would not be available to us this year. A lot of the PX stuff had been in Texas. We have many signs, banners, coolers on legs and casters, and our 50 guideon's. A small climate controlled self storage unit is a minimum of \$30 a month or \$360 a year. So in negotiations the hotel agreed to store everything for us at no charge. Fred Lewis built a hinged box. Casters were donated and the box is labeled "281st". Thanks not only to Fred but Don Torini and Gary Stagman.

The hotel has committed to keep our \$59 rate thru 2008 then \$2 additional each year thru 2012. The association has not committed beyond 2007. So I invite anyone who wants to see the reunion move geographically to find competitive rates or a source of funding to keep member costs down. You will need troops on the ground for planning. If anyone feels they have competitive rates contact me and I will send them a reunion checklist.

The reunion profit/loss was placed on the HQ and may be included with this newsletter. I don't know of another hotel facility that will allow us to bring in the food and beverage as we do here. Anheuser-Busch again donated the beer but amazingly we went thru as much water as we did beer. -

Notes and Comments

Following is a very special open letter to the membership written by Robin Hicks. During the General Memership meeting at the Reunion Robin requested to speak. And speak he did! For upwards of thirty minutes..... You could have heard a pin drop!! - Fred

I want to thank everyone who attended this last reunion for allowing me to speak during the General Membership Meeting. I was not on the agenda and was not planning on participating. I was there to simply listen and get current with what was going on.

I heard some comments during the discussions that bothered me and as I stood there and thought about those things I realized that I had to say something. I knew that if I did not say something, that I would obsess about it later, that I would experience feelings of anxiety, anger at myself, disappointment with myself, loss of self esteem for not being able to do what I thought should be done, depression, guilt, and more. I also knew these feelings would stay with me, not just for a few days or weeks but for years. They would never completely go away. I would remember that day and regret that I was not able to do something that I felt was so important. I would feel guilty at not being able to provide you with information that I felt would be of value, both to each of you personally and to our Organization as a whole.

This was the first time that I was able to stand before a group and say the things I said. Previously, I could only talk about these things in therapy groups where everyone there had been diagnosed with PTSD, or to individuals who were experiencing symptoms and were looking for answers. These individuals are at the top of my priority list because I know about the hurt and pain they suffer through, it is literally unbearable at times, I have felt it for years and continue to feel it almost every day. You will not see it in me because I will not let it be visible. I have had to hide this in order to fit in and survive in this "REAL WORLD" of ours for the last 38 years.

I was emotionally overwhelmed at the attention you gave me, the amount of time that you allowed me to talk and to the response I received when I finally had to stop. When I walked away from the podium, I got choked up and had tears in my eyes before I reached the back wall where I stood and tried to hide. I have tears in my eyes right now just thinking about it.

To conclude this Newsletter here is another message from Robin Hicks. Robin is very knowledgeable about Agent Orange as well as PTSD. His article is a "must read" for any Viet Nam veteran. - Fred



I was asked a couple of questions about Agent Orange at the reunion and would like to provide some information regarding Agent Orange exposure.

Presumptive Service-connection: Any veteran who served in Viet Nam between January 9, 1962 and May 7, 1975 is presumed to have been exposed to herbicides (Agent Orange), if you were there, no further proof is required that you were exposed. This information was extracted from Public Law 102-4, the Agent Orange Act of 1991. You do not have to provide any proof that you were exposed if you were in country during those dates.

All Viet Nam vets who served in Vietnam are also eligible to receive an Agent Orange Registry health examination. Contact the nearest VA medical center to request an examination. If you have any problems at a VA medical center go to the Patient Advocate at that center and have a talk with him. I have gone to the patient advocate twice when I was about to give up on something because I kept getting the runaround....in both cases I was contacted the next day by people who were taking action to get my concerns resolved. In one case I got a personal call from supervisor of one of the doctors I was having a problem with. You can also go to a web site for more detailed information, I took their exam and have been receiving a newsletter about Agent Orange every month. Go to www.VA.gov/AgentOrange.

If all else fails go to a Vet Center and they will help you! www.vetcenter.va.gov/ will tell you where to find them.

Vet Centers can provide you with some of the best help and assistance available. The Vet Center program was designed specifically to treat veterans and their families for trauma-related emotional difficulties. They specialize in PTSD, but are there to help you with any kind of emotional difficulties you may be experiencing, no matter what the cause. Post Traumatic Stress effects everyone, the vet centers treat a large number of Vets where the trauma was a result of things experienced in combat.

The symptoms of Post Traumatic Stress have been recognized throughout time. The Roman Soldiers had to deal with it, as did the American Indians. These societies accepted it and dealt with it and helped those exhibiting the symptoms, helping them integrate back into their societies. In the 1860's this emotional response was called "**railroad Spine**" (workers had been exposed to life threatening accidents and were reluctant to return to work), during the Civil War it was called "**soldiers heart**" (it occurred as a result of combat), World War I called it "**shell shock**", during World War II it became "**battle Fatigue**", the Korean War used the term "**gross stress reaction**", Viet Nam was different because there were so few battlefield emotional casualties. The military had done studies based on surveys and information they had obtained during World War I and II. They discovered that it normally took over 13 months of exposure before someone exposed to the trauma would start developing visible symptoms. Does anyone want to guess what was the determining factor in the length of our tours? What did happen was that they discovered that the symptoms did start showing up later, after the one year tour was completed. They called this "**delayed stress reaction**" or "**post-Vietnam syndrome**". In the late 1970s other terms started to be used to describe the same emotional responses in civilians exposed to other types of trauma like "**rape trauma**", "**battered woman syndrome**", "**police officers shooting trauma**" and "**abused child syndrome**".

In the late 1970s the Disabled American Veterans (**DAV**) sponsored psychological research into the emotional aftermath of battle on Vietnam veterans. The research was called the **Forgotten Warrior Project**. As a result of that research the DAV opened centers in 70 cities around the country to help the vets with counseling, help in getting veterans benefits and providing assistance in other areas where help was needed.

In the early 1980s the Veterans Administration (VA) started their Vet Center program. This was in response to the success the DAV had in developing treatment techniques and in providing much needed help to veterans. The Vet Center program was designed specifically to treat veterans for trauma-related emotional difficulties.

Post Traumatic Stress has been recognized throughout history, **Post Traumatic Stress Disorder (PTSD)** has only officially been recognized since 1980 when the American Psychiatric Association included it in their official

diagnostic manual. The current diagnostic manual is used worldwide as the bible of mental difficulties. Everyone will likely experience post traumatic stress in their lifetime, some of us will be diagnosed with the disorder, a disorder that is extremely serious and impacts our lives and how we are able to interact with others. **The criteria for being diagnosed with PTSD is extensive and the negative impact it must have on your life is extreme.** I have the diagnostic criteria and can provide it to those who may be interested. I will do this at a later date if the interest is there.

I want to give you 2 definitions of PTSD.

- PTSD is a set of symptoms that surface after a very dangerous, frightening, and uncontrollable traumatic event.
- **PTSD is the normal reaction of a normal person to abnormal circumstances.**

We are not crazy or mentally ill, we are not weak minded, defective, deficient or loose cannons that are so dangerous that we should be locked away somewhere. We are just like you, but for some reason have not been able to get past experiencing the symptoms of post traumatic stress. It continues to control us, we see this and we fight it, but are unable to stop it, this causes frustration, confusion and feelings of being helpless. We do not like ourselves because we do things, that we realize later, hurt people close to us. We want help but are either in denial or are afraid to seek help because of the negative stigma that many people associate with PTSD.

I put the above paragraph in to emphasize what I said at the Meeting in St. Louis. Please do not give up on us. We need your help but are afraid to ask you for it. We are afraid of contact, we need and desperately want that contact but are afraid that if we do make contact we might do something that will offend or drive you away forever.

If we hide, we think we can still keep some kind of connection with you, if we drive you away we lose you forever! Learn more about us so you can understand how we feel and accept us as we are. Let us know that you care and that we will be welcome, and that we will not lose you due to something we might say or do that we had no control over at that time. this is hard to express because I am talking about things that might be so insignificant to you that you would not even notice them, but to us they grow huge and we attach things..did I say that wrong...could he have misunderstood and thought....should I have said that or used that word...why did I just do that...is he going to think ? now. It is kind of like being paranoid about everything!

If anyone wants to e-mail me direct with any questions or comments, I will keep who you are or what you say in strict confidence! You can talk to me and what you say will never be repeated. I know how it is, I have been there, I am still going through it and I am fighting it with everything I have. - Robin rkicks@mindspring.com
